Extract from the Joint Strategic Committee - 12 September 2017

JSC/032/17-18 1st Capital Investment Programme & Projects Monitoring 2017/18

Before the Committee was a report by the Director for Digital & Resources, copies of which had been circulated to all Members and a copy of which is attached to the signed copy of these Minutes as Item 6.

The report updated the Committee on the progress and expenditure position for the 2017/18 Capital Investment Programmes for both Adur District Council, Worthing Borough Council and the Joint Services capital schemes included within these programmes.

The Officer updated Members on the improvement work that was being undertaken to ensure that the Councils' delivery capacity was increased to meet high demand within the Capital Programme, both in Adur Homes and corporately.

An Executive Member questioned why within the Worthing Customer Services portfolio on the Capital Monitoring Summary 2017/18, the budget reprofiled to and from 2018/19, had decreased to £1,826,500. The Officer responded to the Executive Member's satisfaction.

Following a question from a Member in the public gallery regarding the section 'Issues for Consideration' (Brighton and Hove Football Club 3G Pitch), within the report, an Officer assured the Member the decision to release the £630,000 contribution to the Sir Robert Woodard Academy, funded from S106 receipts, would be controlled and openly reported as part of the democratic process.


That the Joint Strategic Committee:-

- (a) With respect to the Capital Investment Programme of Adur District Council -
 - (1) noted the reprofiling and likely reprofiling of the Adur District Council capital schemes as advised in paragraphs 2.1.1 and 2.2.2 and Appendix 3;
 - (2) approved the amendment to the 2017/18 Street Scene Budget to include the grant of £2,000 received from West Sussex County Council for the purchase

of benches within the District as detailed in paragraph 2.1.3 i);

- (3) approved the Ferry Road Footpath Access to Shoreham Beach Landscaping Scheme, funded £20,500 from Rampion Offshore Wind Ltd and the balance from the underspend on the Ferry Road Improvements Scheme as advised in paragraphs 2.1.3 ii);
- (4) **recommended** to Council the amendment to the 2017/18 Capital Investment Programme to include the contribution of £630,000 to the Sir Robert Woodard Academy for the construction of a 3G pitch, funded from S106 receipts, as detailed in paragraphs 2.1.3 iii) of the report; and
- (5) **recommended** to Council an increase of £190,000 in the 2017/18 General Fund Budget for Affordable Housing Grants to Registered Social Housing Providers, funded by Right to Buy receipts and S106 Affordable Housing Receipts received by the Council, and to delegate approval to allocate this funding as schemes are identified to the Head of Housing, Chief Financial Officer and the Executive Member for Housing, as detailed in paragraphs 2.1.3 iv) of the report.

Extract from the Joint Governance Committee - 26 September 2017

JGC/028/17-18 Joint Independent Remuneration Panel Report on the Scheme of Members Allowances for Adur District Council

Before the Committee was a report by the Monitoring Officer, copies of which had been circulated to all Members and copies are attached to the signed copy of these Minutes as Item 14.

The Committee received a report from the Joint Independent Remuneration Panel (JIRP) on Members allowances for Adur District Council ("The Council"), for the municipal year 2018/19. The report recommended that the Council (via this Joint Committee) consider two options for uplifting Members Allowances, as detailed in the report.

The Committee was informed that Barbara Nye had retired from the Joint Independent Remuneration Panel. The Chairman wished to place on record the Committee's thanks for Barbara's work on the Panel.

The Committee was advised that over the past couple of years, the JIRP had been seeking to bring Member Allowances in Adur, in-line with those paid in Worthing. Two proposals had been put forward for the Committee's consideration with the JIRP recommending the adoption of Option 2.

The JIRP Chairman, informed the Committee that the Basic Allowance paid to Members of Adur District Council was one of the lowest on the local area. The adoption of option 2 would increase the basic allowance to £4.5k.

It was stated that Adur Councillors had not supported increases to their basic allowance for a considerable period of time, which had led to a discrepancy in the level of basic allowance paid in comparison with colleagues in Worthing. It was suggested that Councillors in Adur should receive a similar basic allowance to that paid by Worthing Borough Council and that such as increase would also help to encourage more young people to stand as Councillors.

A Member sought clarification regarding the increases in budget outlined in paragraphs 5.1 and 5.2 in the report. Officers agreed to check the figures again and report back after the meeting.

Another Member expressed sympathy for the staff in Adur and Worthing Councils who had been restricted by a 1% pay cap for a number of years. Therefore, it was suggested that Option 1 would be more appropriate at this time.

Resolved,

That the Joint Governance Committee considered the report and recommended the adoption of Option 2 to Adur District Council, for the municipal year 2018/19.

JSC/049/17-18 Our growing regional economy - the Greater Brighton Economic Board

Before the Committee was a report from the Director for the Economy, copies of which had been circulated to all Members and a copy of which is attached to the signed copy of these Minutes as Item 6.

The report provided the Committee with an update on benefits Adur and Worthing had gained from the Councils' membership of the Greater Brighton Economic Board, which included:

- Securing £150m of Growth Deal funding held by the Coast to Capital Local Enterprise Partnership (Adur and Worthing Councils had secured £28.2m to support a number of projects);
- advocating for local infrastructure issues at regional and national level;
- promoting economic development as part of the City Region.

The report requested the Committee recommend, to meetings of Adur and Worthing full Councils, that Crawley Borough Council join the membership of the Economic Board. It was noted that this expansion of the membership, to include Gatwick Airport, would further strengthen the Board's position as a voice for economic development, advocating for the City Region locally, nationally and internationally.



JSC/053/17-18 Proposed Submission Shoreham Harbour Joint Area Action Plan

Before the Committee was a report by the Director for the Economy, copies of which had been circulated to all Joint Strategic Committee Members prior to the meeting. A copy of which is attached to the signed copy of these Minutes as Item 11.

The report sought consideration of the Proposed Submission Shoreham Harbour Joint Area Action Plan (JAAP), along with its supporting documents. Members were asked to take account of the comments from the Adur Planning Committee and the Joint Strategic Committee was asked to recommend that Adur District Council approve the publication of the JAAP for six weeks, and submission to the Secretary of State for independent examination.

Members noted that the JAAP formed part of the development plan for both Adur and Brighton & Hove. The JAAP built upon and complemented the Adur Local Plan (currently at examination stage), and Brighton & Hove City Plan Part One (adopted 2016). The Proposed Submission Shoreham Harbour Joint Area Action Plan was attached as Appendix 1. A summary of the amendments to the revised draft plan was attached as Appendix 2. The Sustainability Appraisal and its non-technical summary were attached as Appendices 3 and 4.

- noted the contents of the report, including the comments of the Planning Committee of 18 September 2017, the Proposed Submission Shoreham Harbour Joint Area Action Plan and Sustainability Appraisal; and

Extract from the Joint Senior Staff Committee - 17 October 2017

JSnSC/006/17-18 Supporting the development of our local NHS

Before the Committee was a report by the Director for Digital & Resources, copies of which had been circulated in advance of the meeting and a copy of which is attached to the signed copy of these Minutes as Item 6.

The Committee was informed that over the last four years, the Councils had developed a strong reputation for leadership, innovation and service delivery amongst its partners, along with a capacity to improve key services to residents. The Councils had also helped drive improvements to wider public service delivery with partners for the benefit of local communities.

The health and wellbeing of residents was a fundamental requirement for a vibrant and successful economy and for thriving and resilient communities and as such, was at the heart of the Platforms for our Places strategy.

Over the past 3 to 4 years, the Chief Executive had played a significant role in the local health and social care field, being a member of the Health and Wellbeing Board and with a leadership role around health end equalities. As a result, the Chief Executive had forged constructive working relationships with a number of key health partners including the Coastal West Sussex Clinical Commissioning Group (CCG).

The report set out the on-going work that Adur and Worthing Councils were engaged in with the NHS and West Sussex County Council to improve and develop health and social care services at the local level. As a result of this work the CCG had approached the Leaders of the Councils to explore a secondment opportunity for the Chief Executive to provide leadership to the CCG and the broader health and social care systems in developing the Accountable Care Partnership.

It was proposed that the Chief Executive would work for a period of 18 months on secondment to the Coastal West Sussex CCG. The secondment would attract a salary payment of £56,000 (£74,626 with on-costs) which would be fully funded from the Coastal West Sussex CCG and the Councils would see an overall reduction to their budgets of £60,911.

Members were assured that the day to day running of the Council and delivery of operations would be managed by the well established senior management team in conjunction with the organisation leadership team.

The Joint Senior Staff Committee was asked to recommend that Adur and Worthing Councils approve the proposed groundbreaking secondment arrangements, for the Chief Executive of Adur & Worthing Councils.

A Member sought clarification over the secondment arrangements and the availability of the Chief Executive. Officers advised that the Chief Executive would be available by phone and email and continue to be available throughout the week as he would be working locally. It was noted that Monday's and Thursday's had been nominated as the days for secondment but there would be flexibility in the arrangements.

The Committee expressed support for the proposals acknowledging a number of significant benefits for Adur and Worthing, including:-

- building upon the successes of partnership working between Adur and Worthing Councils;
- improved, local preventative services;
- greater Democratic participation on Local Community Networks;
- reduced fragmentation in the delivery of local public services.

Resolved,

The Joint Senior Staff Committee

- noted the actions and roles that Adur & Worthing Councils (both officers and Members) had been playing in the local developments of stronger Health and Social Care services;
- supported the secondment of the Chief Executive to the Coastal West Sussex Clinical Commissioning Group on the terms set out in the report and recommended to Adur and Worthing Councils that they agree the proposals;

- v) the piecemeal approach to consulting on the A27 improvements failed to take a holistic view of the problems along the length of the A27 corridor nor assess in sufficient detail the cumulative impact of improvements (or decisions not to proceed with certain improvements).

Report by the Director for Communities

1.0 Summary

- 1.1 To note the election of Councillor Lee Cowen, representing the Labour Party for Mash Barn Ward, has affected the political balance on the Council.
- 1.2 To note the re-calculation of the political balance on the Council.
- 1.3 To determine the membership of the 8 seat committees on the Council.

2.0 Background

- 2.1 At the Council meeting in July, Council determined a number of matters related to decision making by the Council until May 2018. This report is referenced here: this was based on the political balance and allocation of seats after the resignation of Councillor Ken Bishop from the UKIP group.
- 2.2 Subsequently a by-election in the Mash Barn Ward has taken place following the resignation of Councillor David Lambourne from the Council on 5 July 2017.
- 2.3 Decision making is governed by the Local Government Act 1972, the Local Government and Housing Act 1989 and the Local Government Act 2000 and Local Government and Public Involvement in Health Act 2007 where this relates to Executive arrangements.
- 2.4 The new calculation of the political balance of the Authority is

3.0 Proposals

- 3.1 Council is asked to note the new political balance of the Council, as set out in 2.4 above.
- 3.2 The effect of the revised political balance on 8 seat committees is the loss of 1 UKIP seat on both the Joint Overview & Scrutiny Committee and the Adur Overview & Scrutiny Committee and the reallocation of both seats to the Labour Group.
- 3.3 The Labour Group need to give notice of the member(s) to sit on the Committees outlined above. The Labour Group may wish to revisit its current representation on Committees to facilitate the take up of these seats.
- 3.4 The UKIP Group need to give notice of the member(s) relinquishing the seats as detailed in 3.2.

4.0 Legal

- 4.1 s106 Local Government Act 1972 provides that Councils may make standing orders for the regulation of their proceedings and business
- 4.2 s111 Local Government Act 1972 provides that the Council shall have the power to do anything which is calculated to facilitate or is conducive or incidental to the discharge of any of their functions.
- 4.3 s15, 16 and 17 of the Local Government and Housing Act 1989 set out powers and duties in relation to political balance on Committees and the exceptions and exemptions therein.
- 4.4 Local Government Act 2000 as amended by the Local Government and Public Involvement in Health Act 2007 sets out regulations regarding appointments to Cabinet and Committees in Councils that have adopted Executive arrangements.

5.0 Financial implications
