The Chairman made the following announcements

It was a great pleasure to Chair the International Women's Day event at Shoreham Community Centre on March 8 which included some inspirational speakers including ClIrs Debbie Kennard and Lavinia O'Connor. There was a great turnout and a real sense of sisterhood and achievement.

Other highlights from the past eight weeks included attending the official opening of the Adur Tidal Walls Scheme. This project has been difficult for some residents - particularly those living on Shoreham Beach - but it's comforting to know that the town is now protected from rising sea levels and river flooding.

I was also delighted to attend Shoreham Fort last month, along with the MP Tim Loughton and West Sussex Cabinet Member for Safer Communities, Cllr Debbie Kennard. It was a total surprise to the Friends of Shoreham Fort when they received a High Sheriff's Award from Caroline Nicholls.

This award was totally well deserved and Gary Baines, Sharon Penfold and the team continue to do an absolute sterling job to protect Adur's only ancient scheduled monument.

Defibrillator Appeal - This continues to be a great success and has gone from strength to strength.

Since the last update, we have successfully installed two more public defibrillators in South Lancing - at the parish hall in South Street and the Lions Hall in Roberts Road. Sincere thanks to both Lancing Parish Council and the local Lions Club for match funding these, along with the Sussex Heart Charity.

A further machine was unveiled at the Miller and Carter restaurant in North Lancing yesterday (Wednesday). This was funded by residents Faye and Terry Ritchie.

Looking ahead, Cllr Lee Cowen has led the fund-raising for a defibrillator in Mash Barn - hopefully the venue will be confirmed shortly.

I am also optimistic that we will shortly be able to confirm funding for life-saving machines in Southwick and Fishersgate.

Congratulations to Cllr Steve Chipp who ran the Brighton Marathon earlier this month and raised sponsorship cash for the Shoreham Lifeboat Station. Well done Steve - I hope your legs have recovered!

I also have great respect for Cllr Paul Mansfield who slept rough for a week during one of the coldest spells of the winter to raise funds for the Turning Tides project, which aims to support people out of homelessness to regain their independence. Please do support Paul's Just Giving Appeal if you can.
