#### Introduction

The applicant HMB and PMT Ltd., is a small local enterprise, owned and managed by Mr Hassan Moghaddam-Bizaki.

The company has taken the opportunity to acquire this site on Shoreham Beach, which having been unoccupied for some time has now received substantial investment.

Mr M-Bizaki proposes himself as the DPS and will bring his extensive experience in the licensed trade to this site, which will be fitted out to a high standard.

The company's intention is for these premises to be an asset to the community and to operate with a wood fired pizza oven in this location, providing a high quality food offer, complimented by alcohol sales. [Proposed menu attached]

#### The Application.

This application was submitted in August 2018 and the operating schedule has been carefully worded to reflect the company's intention to run a genuinely food based business at this site.

The proposed hours have been reduced by agreement with the Licensing Officer and the company fully understands the Licensing Authority's policy approach, aimed at ensuring the balance of premises and licensed hours within Adur District in order to support fully the Licensing Objectives in the Licensing Act 2003.

The applicant believes that they have offered a number of statements in each of the parts of section M of the application demonstrating a genuine commitment to support the Licensing Objectives in full, including:

- Closed Circuit Television System
- Staff training and Challenge 25
- Delivery Service.

#### National licensing policy

The Secretary of State's Guidance under section 182 of the Licensing Act 2003 states:-

Crime and disorder

2.1 'Licensing authorities should look to the police as the main source of advice on crime and disorder.....'

The applicant would like to point out that Sussex Police have entered into an agreement in relation to this application and the Licensing Authority is invited to assume that if the Police had anticipated significant detrimental effects on the Licensing Objectives, particularly The Prevention of Crime and Disorder, they would have made these clear by presenting representations to the Panel.

#### Planning and building control

14.64 The statement of licensing policy should indicate that planning permission, building control approval and licensing regimes will be properly separated to avoid duplication and inefficiency.

The planning and licensing regimes involve consideration of different (albeit related) matters.

Licensing committees are not bound by decisions made by a planning committee, and vice versa.

14.65 There are circumstances when as a condition of planning permission, a terminal hour has been set for the use of premises for commercial purposes. Where these hours are different to the licensing hours, the applicant must observe the earlier closing time. Premises operating in breach of their planning permission would be liable to prosecution under planning law. Proper integration should be assured by licensing committees, where appropriate, providing regular reports to the planning committee.

The applicant would respectfully draw the attention of the Panel to this National Guidance and also state that the Company immediately reduced the proposed hours when the planning permission restrictions on the premises were pointed out.

During the course of the refurbishment, a Building Control Officer attended the site and the applicant has complied with the officer's requirements, including those relating to fire and insulation.

#### **Premises Licence Conditions**

The applicant has proposed comprehensive Premises Licence conditions agreeing the wording with Sussex Police and would like to bring the Panel's attention to two further matters:

Firstly, a high quality CCTV system has already been installed at the premises, with nine High Definition cameras and a 4 TB Hard Drive. The cost was in excess of £1,500. [Details attached].

Secondly, the applicant will maintain a compliance file at the premises to ensure compliance with the Premises Licence conditions, should the Premises Licence be granted.

HMB and PMT Ltd. is open to any further conditions that the Licensing Control Sub-Committee might consider to be necessary, particularly where communication with local residents is concerned.

#### The Representations

The s182 Guidance to the Licensing Act 2003 states

9.36 As a matter of practice, licensing authorities should seek to focus the hearing on the steps considered appropriate to promote the particular licensing objective or objectives that have given rise to the specific representation and avoid straying into undisputed areas......

Originally, five representations were submitted by local residents, however, since the applicant reduced the proposed authorised hours only two representations remain.

The applicant would like to point out that the remaining representations are not explicitly linked to a licensing objective or licensing objectives.

Both letters refer to 'Need', which in this context is not a relevant consideration.

Both letters refer to various matters, including anti-social behaviour in the area, which are not related to this site.

The applicant believes that he has addressed the main issue, which is to reduce the proposed authorised hours to 22.30hrs daily.

However, the applicant does not wish to minimise the concerns of local residents and will do everything possible to support the Licensing Objectives, should a premises licence be granted.

In addition, Mr M-Bizaki is very willing to receive comments from neighbours and to work in partnership to resolve any local issues that may arise in the course of business for this new Pizzeria.

The applicant has met with the family from A Ferry Road and in the course of an amicable conversation, explained his business plan and gave assurances about future dialogue.

#### Conclusion

The applicant, HMB and PMT LTD., has submitted this premises licence application to support their business plan to create a pizzeria at this location.

The applicant has carefully assessed the impact of the premises licence application and they believe that they can fully support the Licensing Objectives in the Licensing Act 2003.

The applicant has complied with the local statement of licensing policy and consulted with the Responsible Authorities in advance of the application and agreed licence conditions with the police, investing considerable funds in refurbishing the site and installing an HD CCTV system.

HMB and PMT Ltd. would like to state that the company understands the necessity for balance between the needs of business and the needs of residents.

In this case the company has refurbished this site and intends to make every effort to be responsive to local residents' concerns, whilst operating a responsible business in support of the Licensing Objectives in the Licensing Act 2003.

The members of the Adur District Council Licensing Control Panel are respectfully requested to grant the application for this premises licence with any premises licence conditions that they consider appropriate.
