Outside Body Appointments 2009/10

Report by the Executive Head of Legal and Democratic Services

1.0 Summary

1.1 This report asks the Leader to consider the nominations received from Members for appointments to the Council's Outside Bodies and make a recommendation to the Annual Meeting of the Council on 19 May 2009.

2.0 Background

- 2.1 Each year, the Council appoints Members to represent the authority at meetings of various local organisations, such as community groups, referred to as Outside Bodies. These appointments strengthen the links and aid communication between the Council and the community and contribute to the role of local Councillors.
- 2.2 In previous years, these appointments have been determined by full Council at the annual meeting. However, following recent amendments to the Constitution with the aim of easing this process, the Leader of the Council now has delegated powers to consider the nominations received from Members and make a recommendation to Annual Council.
- 2.3 Each of the Council's current Outside Bodies were consulted regarding their appointment(s) in early April 2009. Following this, all Councillors were invited to submit their nominations. Details of the nominations received, together with any supporting information submitted by Councillors, are set out in Annex A.
- 2.4 Details of the Council's Outside Bodies and current appointments are set out in Annex B.

3.0 Outside Bodies - Appointment Details

3.1 Each Outside Body has specific requirements regarding their appointment(s) such as any special skills or interests required. These are set out in full in Annex B. The Leader is asked to consider each of these requirements when determining the recommended appointment(s). Details are highlighted below:

3.2 **Outside Body No. 2 - Adur Community Leisure - Board of Trustees:**

Appointments to this Outside Body are for a maximum term of 4 years. One of the two current appointments has been in place since 2005 and therefore will need replacing.

3.3 **Outside Body No. 3 - Adur Community Safety Partnership:**

The appointment to this Outside Body should be the Cabinet Member for Health Safety and Wellbeing.

3.4 **Outside Body No. 7 - Adur Editorial Board:**

The 4 appointments to this Outside Body should include representation from each political group on the Council.

3.5 **Outside Body No. 9 - Adur Homelessness Forum:**

The appointment to this Outside Body should be the Cabinet Member for Regeneration.

3.6 **Outside Body No. 11 - CenSus Joint Members Steering Group:**

The appointments to this Outside Body should be executive members (i.e. Cabinet Members).

3.7 Outside Body No. 29 - Shoreham Harbour JAAP - Member Steering Group:

The appointments to this Outside Body should include the Leader, the Cabinet Member for Regeneration and a Ward Councillor local to the harbour area.

3.8 **Outside Body No. 32 - South East Employers:**

The appointment to this Outside Body must not be an employee of another local authority.

3.9 Outside Body No. 33 - West Sussex Health Overview and Scrutiny Committee

The terms of reference of this Outside Body were amended in October 2008 and as such Adur District Council now has one seat on the Committee (rather than 1 seat shared with Worthing Borough Council as in previous years). The appointment to this Outside Body must therefore be one Adur District Councillor, who must be a member of Overview and Scrutiny.

3.10 **Outside Body No. 39 - West Sussex Supporting People Commissioning Body:**

The appointment to this Outside Body should be the Cabinet Member for Regeneration (or their Policy Advisor).

4.0 Legal

- 4.1 Involvement in Outside Bodies is part of the key role and duties of a District Councillor, as set out in Article 2 of the Constitution.
- 4.2 The terms of reference of the Leader of the Council, as set out in Part 3 of the Constitution, include the consideration of appointments to Outside Bodies.
