Record of Decision: Review of Mental Health Services in West Sussex

Decision taken by: Leader

**Declaration of Prejudicial Interests:** I hereby confirm that I **do not** have a prejudicial interest in this item.

Declaration of Personal Interests: None

#### Decision:

- 1. that the direction of travel is understood, however, there is still a lot to do to provide adequate Community Mental Health Services;
- 2. Community Mental Health Teams need to be available for 24 hours and a short extension to the current hours of availability is not sufficient;
- 3. that there needs to be a system for making sure those suffering from schizophrenia or psychosis take their medication when in the community;
- 4. that the expectation for each psychological therapist in a primary care location to handle 1000 cases is unrealistic;
- 5. that concern is expressed regarding the public consultation statement that 'the reduction in inpatient beds does not require further investment in community services', it is the held belief that significant further investment is required;
- 6. that those suffering from dementia in nursing homes need better care and attention;
- 7. that there needs to be better provision of respite care for carers of those with mental health issues;
- 8. that it is understood that along with a duty of care to those with mental health issues comes a duty to protect the general public.
- 9. that concern be expressed that the email address provided in the consultation was incorrect and may have prevented some people from responding to the consultation.
- 10. Although the current proposals do not specify a direct reduction in the provision of mental health services in Adur at the moment I am concerned that the Councils were not consulted on previous alterations to the service when there were reductions in the service at that time.
