1.0 Summary

- 1.1 The Leader is invited to consider and appoint Councillors to organisations as detailed below:
- 1.2 Those vacant following the resignation of Mike Mendoza from the Council Shoreham Airport Consultative Committee (substitute vacancy) and the Shoreham Port Authority Local Authority Liaison Committee
- 1.3 A new organisation the Sompting Big Local Partnership

2.0 Background

- 2.1 Details of the two organisations with vacancies following the resignation of Mike Mendoza from the Council are attached to this report.
- 2.3 The Big Local is a new organisation, details are attached as provided to the Council. The organisation has specifically indicated to officers that it would like Councillor Carson Albury as its representative.

3.0 Proposal

- 3.1 The Leader is invited to consider the attached supporting information on the three organisations and determine the Council representation in each case.
- 3.2 The Constitution adopted in July which commenced in 1 November has new arrangements for the appointment of council representatives. These are expanded upon in paragraph 4.0.

4.0 Legal

4.1 Local Authorities (Functions and Responsibilities) (England) Regulations 2000 allows certain functions and responsibilities to be determined locally 'local choice functions'.

4.2 The Council has determined in the Constitution (Part 3 Section 3) that the 'appointments to outside bodies in connection with the functions which are the responsibility of the Executive' is an Executive function with the decision maker being the Leader.

5.0 Financial implications

5.1 Normal travel and subsistence rates could be claimed under the Council's adopted Members Allowance scheme. As the organisations are within Adur, mileage would be low and could be contained in the existing budget.

6.0 Recommendation

- 6.1 The Leader is invited to consider the information in support of the three organisations and determine the Council's representation as follows
- 6.2 Appoint a replacement member for the vacancies on the Shoreham Airport Consultative Committee (substitute) and the Shoreham Port Local Authority Liaison Committee until the Annual Meeting in 2015.
- 6.3 Appoint a representative to the new organisation 'Sompting Big Local Partnership' to the Annual Meeting in 2015.
