#### **Decision:**

- 1.Cabinet member agrees the work program as laid out in para 3.2 of the report CSE-017/11-12 with regular reporting of budget and project schedule to the cabinet member.
- 2.Cabinet member approves the staffing resource to be used as per para 3.4.1of above report except with prior approval if agency or consultant is appointed, with a review period of the staff member taking place after 18months, to ensure value for money and ensuring that the project is being delivered SMARTly.
- 3.to note legal advice as per para 4.1 of the report .para 4.2 states that the lease places responsibility upon the leaseholder, this is being checked by the officers as to the precise position with regard each flat and this is to be reported to the cabinet member. Para 4.3, the council is to work with the leaseholder so as not to create a barrier with the leaseholder over the replacement of the front doors if a cat 1 hazard under the Act is issued to the leaseholder and that a method of replacement with reasonableness and if required discussions as to how the leaseholder can pay for the replacement bearing in mind the current capital schemes taking place at the present time that need large leaseholder consultation and funding.
- 4. to note that a report will be submitted to JSC on 28/2/2012 with detail of re-profiling of the 2012/3 capital housing budget.
