Record of Decision: Dog Control Orders - Response to Statutory Consultation

Decision taken by: Cabinet Member for Clean and Green Environment

Declaration of Prejudicial Interests: I hereby confirm that **do not** have a prejudicial interest in this item.

Declaration of Personal Interests: I have a personal interest as an occasional walker of the family dog.

Decision:

- (i) That the 'Dog Exclusion' order is amended to make it clearer to the public which areas of land are intended to be dog free;
- (ii) That the proposed orders in Annex A are agreed and adopted;
- (iii) That Adur District Council's Legal Services department is instructed to proceed with completing the Orders;
- (iv) That Sussex Police, their Officers and PCSO's are authorised to issue relevant Fixed Penalty Notices for Dog Control Offences.

Reasons for the Decision: To afford the Council greater ability to control the exercising and walking of dogs, keep certain areas clear of dogs, reduce the incidence of fouling by dogs, and contribute to a cleaner and safer environment, making it clearer to the public the area included and ensue the police also have enforcement authority

Alternative Options Considered: To retain the original wording. Leave doubt as to the authority of the police.
