Record of Decision: Review of Adur Off Street Parking

Decision taken by: Executive Member for Environment

Declaration of Disclosable Pecuniary Interests: I hereby confirm that I do not have any disclosable pecuniary interest in this item.

Decision:

The Executive Member:-

- (i) in consultation with the Director for Customer Service authorised under Scheme of Delegations to amend the existing Order via Legal Services / Parking Services as set out in this report to amend the existing tariff and to introduce a nominal charge for Sundays and Bank Holidays in the car parks that do not currently charge on those days and to introduce monthly and quarterly season tickets and to be able to charge for motorists displaying a disabled person badge and to introduce pay by phone method;
- (ii) noted the costs outlined in Section 6 and approved for the necessary expenditure to be made in order to amend the tariffs.

For clarification:

- There will be changes to the daily tariffs and season ticket prices and options as set out in Table 1;
- The charging hours at the following car parks will be extended from 9am to 5pm to 9 to 6pm: Beach Green, Middle Street, Old Fort, Pond Road, Riverside, Riverside including Riverside Permit bays, Tarmount Lane, Ropetackle, Littlecroft, North Farm Road, South Street, Southwick Beach, Southwick Square and Ham Road Car Park;
- A £1 Charge will be introduced on Sundays and Bank Holidays in the following car parks: Middle Street, Pond Road, Tarmount Lane, Ropetackle, Littlecroft, North Farm Road, South Street, Southwick Square and Ham Road Car Park;
- Normal tariffs will apply to motorists displaying a Blue Badge This will apply in all 13 car parks which includes Beach Green, Middle Street, Old Fort, Pond Road, Riverside, Tarmount Lane, Ropetackle, Littlecroft, North Farm Road, South Street, Southwick Beach, Southwick Square and Ham Road Car Park;

- Pay by phone technology will be adopted in all 13 Car Parks which includes Beach Green, Middle Street, Old Fort, Pond Road, Riverside, Tarmount Lane, Ropetackle, Littlecroft, North Farm Road, South Street, Southwick Beach, Southwick Square and Ham Road Car Park;
- The implementation of the review will be subject to the Statutory Consultation.
