**Record of Decision: Adur Competitive Community Grants Budget 2014/15 – Round 3**

**Decision taken by:** Executive Member for Health & Wellbeing

**Declaration of Disclosable Pecuniary Interests:** I hereby confirm that I do not have any disclosable pecuniary interest in this item.

**Decision:**

The Executive Member for Health & Wellbeing has made his decisions concerning the allocation of the 2014/15 Adur Community Grants in line with the agreed criteria as follows:-

**Fishersgate Bike Project (Shoreham Academy)**

Sum agreed £4,800 for the purchase of tools and the setting up of this valuable community project, subject to the sessional worker being for the first year only, with any future co-ordination being provided through the community engagement.

**Friends of Fishersgate Rec**

Sum agreed £4,068 subject to clarification and agreement in relation to some issues around the future events planned, where appropriate, link to Adur Festival and consideration of raising some of the required goods elsewhere through sponsorship.

**Shoreham Football Club**

Sum agreed £4,000 subject to provision of further evidence of need. This project fits in well to our overall strategy of Health and Well-Being, and provides for a whole community response in a club seeking to be at the heart of the local community.

**Sompting Village Morris**

Sum agreed £3,600 as this provides an excellent vehicle to publicise the Adur area as well as bring in business opportunities for local shops and restaurants and assisting in regeneration of the district.

**Southlanders**


Sum agreed £1,080 to support measures to address social isolation of our older community in an area that suffers disproportionately with health needs and other issues of deprivation.

**Adur Hearty Lives Project**

Sum of £30,000 agreed to extend and broaden out the Adur Hearty Lives Project to September 2016. This programme, funded for three years by the British Heart Foundation and delivered by our communities team, now requires additional support to complete its mission across the district schools, as well as providing further opportunities to address wider issues affecting young people.
