**Record of Decision: Adur Community Grants - Allocation of Funds for 2018/19 - Second Round**

**Decision taken by:** Adur Executive Member for Health & Wellbeing

**Declaration of Disclosable Pecuniary Interests:** I hereby confirm that I do not have any disclosable pecuniary interest in this item.

**Decision:** The Adur Executive Member for Health & Wellbeing has considered the allocation of the 2018/19 Adur Community Grants Budget and agreed the following:-

***Application One - Shoreham Light Parade - £1,500.00***

This is a new event which is accessible and inclusive to local residents and wider. The event is run on a shoestring and by a team of hardworking volunteers and this contribution will go a long way to support this venture.

***Decision: £1,500 granted - to be advertised as supported by ADC***

***Application Two - CYCALL - £1,000.00***

Subject to an upcoming visit, the recommendation is to support this new project. The project targets key priorities of the grants - 2 increasing activity for children and adults 3 encouraging teenagers to be fit and healthy, 4 supporting our older residents and 5 reducing loneliness of all ages.

***Decision: £1,000 granted - to be advertised as supported by ADC***

***Application Three - Shoreham Air Training Corps - £2,500.00***

There is no denying that the group is important for the education and wellbeing of young people but the project doesn't reach many of our more vulnerable young people or the wider priorities for the grants.

***Decision: £1,500 granted towards the overall cost***

*The project is seen as an opportunity to train young people in new forms of technology leading to enhanced employment opportunities and is therefore supported in part.*

**Application Four - Fishersgate Youth Club - £5,000.00**

Sussex Clubs for Young People are working incredibly hard in a high area of deprivation, meeting key priority 3 which encourages young adults to learn new skills, activities or interests that keeps them safe, fit and healthy - this will include prevention work around sexual health, drugs and alcohol use and the risk of weapons.

**Decision: £5,000 granted**

An important facility that is increasing its reach into Fishersgate and surrounding areas and which will also assist young people to develop their aspirations leading to greater commitment and future employability.

**Application Five - Shoreham Sailing Club - £5,000****Decision: Not supported**

*This project does not fit comfortably with our priority areas and is therefore not seen as a priority for the limited funding available this year.*
