Irrecoverable Debts

Report by the Chief Financial Officer

1.0 Summary

- 1.1 This report details outstanding former tenants rent arrears and Housing Benefit overpayments which have been the subject of lengthy recovery action and enquiries. The associated debts are now deemed to be irrecoverable and are therefore recommended for write-off.
- 1.2 This is the first report detailing debts over £2,500 to be written off in this financial year.

2.0 Background

- 2.1 Paragraph 8.4 of the Council's Financial Regulations require that irrecoverable debts of Sundry Debtors, Housing Benefit Overpayments and Homeless Accounts and Housing Rents over £2,500 are to be submitted to the Executive Member for Resources for write-off.
- 2.2 All outstanding debts are regularly reviewed and an assessment made as to the likelihood of recovery. The scale of the effort made to collect each debt varies in proportion to the amount outstanding.
- 2.3 Any debt that is written off may subsequently be recovered due to various reasons including a dividend being received in an insolvency case or a debtor being traced.

3.0 Proposals

3.1 The following debts are submitted for write off:

Housing Benefits Overpayments - Irrecoverable debt totalling £11,424.43 covering one account.

Housing Rents - Irrecoverable former tenant rents arrears for two former tenants totalling £8,790.71.

3.2 The current level of bad debt provisions held by Adur District Councils at present before the write offs proposed in the report are:

Adur Overpayments Provision £77k
Adur Housing Rents Provision £395k

(including temporary accommodation)

Sundry Debt Provision £207k

4.0 Legal

4.1 Section 151 of Local Government Act 1972 provides that every local authority shall make arrangements of their financial affairs and shall ensure that one of their officers has responsibility for the administration of those affairs.

5.0 Financial implications

5.1 Considerable resources have already been expended in the effort to collect these outstanding debts. Any further enforcement action would not be cost effective.

6.0 Recommendation

6.1 That the Executive Member should approve the write-off of the debts referred to in paragraph 3.1.
