### **PURPOSE**

The purpose of this report is to consider tenders received under single stage tendering procedures for the Remodelling of Offices & Associated Works to Worthing Crematorium, Findon, West Sussex.

To make a recommendation with a view to tender acceptance and request approval to proceed to contract.

All tenders were invited on a schedule of rates basis, using the In-tend e-portal, with MEAT (Most Economically Advantageous Tender) scoring ratios stated as 30% Price and 70% Quality.

Approval is sought to accept the recommendation for the appointment of Fowler Building Contractors Ltd, as stated at Item 2.1 below.

### I.0 DIGEST

1.1 The project entails the remodelling of staff offices, reception area and waiting room, and washroom facilities.

1.2 Project Budget £337,500.00

1.3 Contract Sum £316,945.00

1.4 Estimated Date of Commencement Tuesday 8th May

1.5 Estimated Date of Completion To be agreed prior to contract

1.6 Contract Duration 12 weeks

1.7 Contractor: Fowler Building Contractors Ltd

### 2.0 RECOMMENDATION

2.1 To accept the overall highest ranking tender received from Fowler Building Contractors Ltd, in the sum of £316,945.00 +vat, and that this contactor is appointed as Principal Contractor, subject to the placement of a contract deed and development of the Construction Phase Health & Safety Plan, prior to commencement of any works on site



### 3.0 PROPOSED WORKS

The proposed works include for the following:

- Fully revised office layout, to include kitchenette
- Relocated, enlarged reception area, with memorialisation display
- Conversion of existing store room and adjacent Vestry into new waiting room
- New store room and Vestry created within existing external courtyard
- Fully refurbished and Part M compliant customer WC
- Creation of additional staff only WC

### 4.0 TENDER

- 4.1 A group of five, suitably qualified contractors, with known relevant experience of working within occupied and sensitive environments, were invited to submit tenders.
- 4.2 Tenders were issued and returned electronically via the In-tend e-portal. Upon return, all documentation received into the In-tend system was electronically transferred/downloaded by Roy Wood (Building Surveyor) on the 16<sup>th</sup> March 2018, with individual tender price submissions formally transferred across to the Tender Summary Form accordingly.

The tendering contractors were:-

- 1) Cheesmur Building Contractors Ltd
- 2) Fowler Building Contractors Ltd
- 3) John Farrington & Co. Ltd

Messrs Tasker Catchpole Ltd and A&F Pilbeam Ltd both opted to withdraw from the tender process prior to the date of return; the former having gone into receivership during the tender period.

4.3 Tenders were invited on the basis of a fixed price contract for a period of 12 weeks.

- 4.4 All the above tenders are exclusive of professional fees and VAT, currently rated at 20%.
- 4.5 Costs associated with the delivery, set up, dismantling and collection of temporary buildings to serve staff decanted prior to commencement do not form part of the tendered sums above.



Technical Services has engaged the services of Messrs Portakabin Ltd, who are to provide said buildings for the duration of the project.

Furthermore, specialist works to run temporary and final ICT network and telephony connections attract an additional cost. These works are to be facilitated by Messrs Aspire Networks Solutions Ltd, in coordination with Adur & Worthing's ICT department.

- 4.6 The subjects of this report are the <u>two highest ranking tenders</u> from a total of the three competitive tenders received. Tender evaluation details are attached to this report in **Appendix A**.
- 4.7 None of the highest ranking two tenders analysed contained any qualifications. However, Cheesmur Building Contractors Ltd provided a series of provisional sums for scheduled work items they felt were insufficiently detailed within the tender documentation. These sums form part of their priced submission.
- Analysis of the priced rates provided by Fowler Building Contractors Ltd revealed an arithmetical discrepancy in the contractor's favour to the value of £1,095.00. A request was sent to the contractor's estimating team for consideration and feedback in relation to this apparent error on 29th March 2018. It was agreed by the contractor's representatives that an error did indeed exist and that, in line with JCT guidance, the tender figure and/or relevant rates within the priced schedules were to be suitably amended and re-submitted to the Council; a covering letter to also be provided.
- 4.9 Details of Contract Preliminaries pricing (tender documents, Section I) were requested of Fowler Building Contractors Ltd on 20<sup>th</sup> March 2018. This information was provided promptly and has been further analysed in support of the lump sum tender price submitted, details of which appear acceptable.



- 4.10 The overall range between the two lowest (price) tenders is £23,542.00 or approximately 7%.
- 4.11 This variance in price can, in part, be explained by each contractor's pricing of individual or 'grouped' work items (elements). However, it would appear that Fowler Building Contractors Ltd has placed a greater onus on the delivery of certain elements outside of 'normal' working hours as stated within the Contract Preliminaries. This is seen as a key consideration, given the sensitivity of the environment in which works are to take place.
- 4.12 By MEAT tender process this project has now been fully market tested. The MEAT evaluation process was undertaken relative to a pre-informed 30% price and 70% quality score assessment, this process has arrived at a recommended tender as submitted by Fowler Building Contractors Ltd, in the sum of £316,945.00.
- 4.13 By MEAT tender analysis on the two highest ranking tenders Fowler Building Contractors Ltd has demonstrated a keen desire to secure the contract; as such it is recommended that the tender submitted by Fowler Building Contractors Ltd is accepted.

## 5.0 FINANCE & INSURANCE

- 5.1 The project is to be funded by Worthing Borough Council (Environmental Services) Capital Funds from the 2018/2019 budget.
- 5.2 The Council's Finance team has provided details concerning the recent trading status and credit rating of Fowler Building Contractors Ltd; this information was limited to the last filed accounts available, dated 31st December 2016. The financial report produced by 'Creditsafe' shows that the Contractor has been trading for nearly twenty years and, as at year end 2016, had a credit rating of 69 out of 100 considered to be *low risk*.

Given the relatively historic nature of the information provided, consideration has been given to the requesting of a copy of the Contractor's summary of accounts to 31st December 2017; details pending.

5.3 The company has provided details of their Public Liability Insurance Cover, which meets this Councils current requirement of £10,000,000.

#### 6.0 DESIGN & SUPERVISION

6.1 Administration and services include for a Contract Administrator and Principal Designer. These roles will be fulfilled by officers within Technical Services' Surveying & Design team.



# 7.0 HEALTH & SAFETY - CONSTRUCTION DESIGN & MANAGEMENT REGULATIONS (CDM)

7.1 Due to the duration of the contract and the nature of the works, all of the CDM Regulations 2015 will apply as detailed within the Pre-Tender Health & Safety Plan. As such, once appinted, the successful contractor will be required to develop their Construction Phase Health & Safety Plan to the satisfaction of the Principal Designer. This must be sufficiently completed prior to any site activities taking place, to enable commencement of the works.

### 8.0 ENVIRONMENTAL IMPLICATIONS

8.1 None identified.

### 9.0 COMPANY REFERENCES

- 9.1 Fowler Building Contractors Ltd has provided details of previous relevant experience within its completed tender submission schedule and throughout its (quality) method statement responses. Referee contact details are also set out, although at the time of writing, it is not considered necessary to seek additional information and/or feedback from these individuals.
- 9.2 Fowler Building Contractors Ltd is a known quantity to officers within Technical Services, and has provided tenders for previous capital projects.

### 10.0 POST TENDER DISCUSSIONS

Discussions have taken place with both Fowler Building Contractors Ltd and Cheesmur Building Contractors Ltd concerning their approach to 'out of hours' working during the contract term. Reponses are outlined within the 'Method Statement Evaluation Matrix', included in **Appendix** A. Both contractors were also advised at the time of discussion that their respective tenders were under consideration.

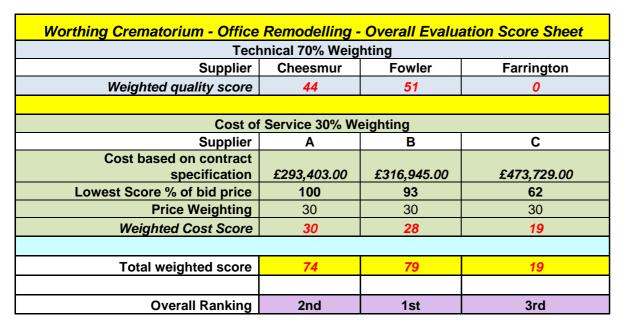
