**Executive Summary** 

#### 1. Purpose

- 1.1 The Food Service Delivery Plan 2018-19 (Appendix A) sets out how Adur & Worthing Councils intend to provide an effective food safety service that meets the requirements of the Food Standards Agency (FSA) Framework Agreement on Local Authority Enforcement. It covers the functions carried out by the Food Safety Team under the provisions of the Food Safety Act 1990, the Food Safety and Hygiene (England) Regulations 2013 and relevant regulations made under the European Communities Act 1992.
- 1.2 The Review of the Food Service Delivery Plan 2017-18 document (Appendix B) reviews the performance against the Food Service Delivery Plan 2017-18.

# 2. Recommendations

- 2.1 The Executive Members are requested to:
  - i) endorse the Food Service Delivery Plan for 2018-19.
  - ii) note performance against the Food Service Delivery Plan for 2017-18.

#### 3. Context

3.1 Each Competent Authority must have an up-to-date, documented Food Service Plan which is readily available to food business operators and consumers. The Plan must be subject to regular review and clearly state the period of time during which the Plan has effect.

3.2 The Plan must cover all areas of food law that the Competent Authority has a duty to enforce and set out how the authority intends to deliver Official Controls within its area.
