C/09/17-18 Decision making

Before the Council was a report by the Director of Communities, copies of which had been distributed to all Members and a copy of which is attached to the signed copy of these minutes as item 9. The report asked Council to note the political balance on the Council, agree some constitutional matters required to be considered at the Annual Meeting and the appointments to the committees and chairmanships for the coming year. The names nominated for the committee seats were the wishes of the various groups on the Council. An amended Annex A had been circulated and is attached to the minutes.

The recommendation was proposed by the Leader, Councillor Humphreys. When making his recommendation the Leader asked Council to note that Councillors Bryan Turner and Clive Roberts had recently resigned from his Cabinet, with Councillor Jenkins and Councillor Guest taking the respective portfolios, Councillor Jenkins would also become Deputy Leader. The Leader went on to thank Councillors Turner and Roberts for their work whilst in his Cabinet.
