#### Local Government (Miscellaneous Provisions) Act 1976 Proposed Increase in the Taxi Tariff

#### **Report by the Director for Customer Services**

#### 1.0 Summary

1.1 Members are requested to consider an application received from Worthing Voluntary Taxi Association for an increase in the Hackney Carriage Tariff.

#### 2.0 Background

- 2.1 Worthing Borough Council has powers under Section 65, of the Local Government (Miscellaneous Provisions) Act 1976 to set a tariff for Hackney Carriages, (Taxis).
- 2.2 The last such increase was authorised 1 June 2010. A copy of the current Worthing Taxi tariff structure is attached marked **Appendix A**
- 2.3 There are 82 Hackney Carriage Licensed drivers 64 are members of the Voluntary Taxi Association.
- 2.4 All 64 members and 17 non-members voted in favour of the tariff proposal.

#### 3.0 Proposal

- 3.0 Worthing Voluntary Taxi Association has presented a proposal letter dated 14 July 2014 to the Adur & Worthing Councils' Licensing Unit for an increase to the current Worthing hackney carriage tariff. **Appendix B**
- 3.1 The proposed tariff has been checked and officers can confirm that the tariff is mathematically consistent and can be programmed into taximeters.

#### 4.0 Legal

- 4.1 The Council has powers under Section 65, Local Government (Miscellaneous Provisions) Act 1976 ("the Act") to set a tariff for Hackney Carriages, (Taxis). It is important that the tariff set is consistent and unambiguous.
- 4.2 If members are of a mind to provisionally approve the increase the suggested tariff must be advertised in a local paper giving the proposed variation in fares, a copy of

the notice must be lodged at the Council offices, available for inspection by the public "at all reasonable hours", and at least 14 days must be allowed after such publication for any objections.

- 4.3 If there are no objections, or any objections made are withdrawn, the new tariff may come into effect on a date which is not less than 14 days after the date of publication, or the date of withdrawal of the last objection, whichever is later.
- 4.4 If there are objections, the Council must consider them unless previously withdrawn. The new tariff, if imposed by members after such consideration, will then come into effect on a date set by the Committee, which is not more than two months after the first specified day.

#### 5.0 Financial implications

- 5.1 There are no direct financial implications for the Council.
- 5.2 Members should bear in mind that the vast majority of taxi drivers are small sole trader businesses, whose income is indirectly regulated by the Council.
- 5.3 The tariff set is a maximum tariff, and drivers are not obliged to charge the full amount shown on the meter, in every case.

#### 6.0 Recommendation

6.1 Members are requested to determine the request from the Worthing Voluntary Taxi association for a new Tariff Scheme.

# Appendix A

The table of fares made by the Council under Section 65 of the Local Government (Miscellaneous Provisions) Act 1976, provides that the proprietor or driver of a Hackney Carriage shall be entitled to demand for the hire of the carriage the rate or fare prescribed by the following table. The fare payable shall be by way of a combination of time and distance automatically calculated and displayed by the Taximeter fitted to the carriage. The taximeter must be switched on at the start of each journey.

Tariff 1. Daytime, (0600 - 2300):

To apply at all times except when Tariff 2, 3 or Tariff 4 applies. For the first 5/9 mile or 250 seconds, or part of £3.00 For each subsequent 1/9 mile, or 50 seconds, or part of £0.20 (For 5 passengers or more, Tariff 2 applies, with no extras)

#### Tariff 2. Night Time, (2300 - 0600),

Between 0600 on  $1_{st}$  January and 0600 on  $2_{nd}$  January And other Public Holidays except when Tariff Three applies: For the first 8/11 mile, or 360 seconds, or part of £4.00 For each subsequent 1/11 mile, or 45 seconds, or part of £0.25

#### Tariff 3. Christmas and New Year:

Between 2000 hr on 24th December and 0600 on 27th December and Between 2000 hr on 31st December and 0600 on 1st January: For the first 10/12 mile or 450 seconds, or part thereof £6.00 For each subsequent 1/12 mile or 45 seconds or part of £0.30

#### Tariff 4. Special Night time rate (2300 – 0600), when starting with five or more passengers No passenger extras may be charged.

For the first 8/11 mile, or 360 seconds, or part of £6.00 For each subsequent 1/11 mile or 45 seconds or part £0.25

#### Extras.

For each passenger in excess of one £0.20

No passenger extras shall apply when a higher rate tariff is in effect because of the number passengers being carried. For each article of luggage carried in the luggage area £0.10 Total of extras shall not exceed £0.80.

#### SOILING OR FOULING CHARGE must not exceed £150

Where a Hackney Carriage is hired and the taximeter is used to automatically calculate the Fare payable for the hiring, the proprietor or driver shall not be entitled to demand or take a fare greater than that recorded on the face of the taximeter.

First 1232 yards or 350 seconds	£6.20p
For each subsequent 176 yards or 50 seconds	£0.30p

Maximum extras to be charged	£1.00p
For each passenger in excess of one	£0.20p
For each article carried in the luggage area	£0.10p
