Licensing Act 2003 Application for a Variation of a Premises Licence under Section 34

'MRH Brooklands – Service Station' 331 Brighton Road Worthing BN11 2HP

Report by the Director for Communities

1. Recommendation

1.1 That a Sub Committee of Licensing & Control Committee "B" considers and determines the application made by:

Malthouse Ltd.

for a variation of the above Premises Licence (No. LN/100001149) which currently authorises the sale of alcohol for consumption off the premise at the above forecourt store.

2. Reasons for the Hearing

2.1 The application has been the subject of formal representation by two responsible authorities. Three letters of representation have been received from members of the public and three petitions received signed by forty one local residents. It therefore falls to this authority to determine the application.

3. Background

- 3.1 An application was made on behalf of Malthurst Ltd. to the Licensing Authority, Worthing Borough Council, on the 5 March 2019 for grant of a full variation to their existing Premises Licence.
- 3.2 This premise has been operated for many years as a service station with convenience store and has recently benefitted from a refurbishment and brand change to 'Budgens'. It is situated on the very busy main coast road, Brighton Road, directly west of Brooklands Park and directly opposite the beach. To the north and east there are residential flats and houses.
- 3.3 Malthurst Ltd. have been the licence holders of the store since August 2017.

- 3.4 The premises is currently authorised to provide:
 - Alcohol sales
 - 08:00hrs until 23:00hrs Monday Sunday incl.
 - Opening to the public
 - o 06.00hrs until 23:00hrs Monday Sunday incl.

In line with the hours of use attached to the site's planning permission.

- 3.5 Attached to the report are:
 - A plan of the area (Appendix A)
 - A plan of the store (Appendix B)
 - A copy of the application (Appendix C)
 - A copy of the current premises licence (Appendix D)
 - Copies of the representations received from the responsible authorities (Appendix E1&2)
 - Copies of the representations received from local resident.

(Appendix F 1- 6)

 Copies of mediation correspondents between applicant & Responsible Authorities (Appendix G 1 & 2)

4. The Application

- 4.1 The application is attached at Appendix C. However, in summary, Malthurst Ltd. are seeking authorisation for:
 - An extension of the opening hours of the store and the hours for the sale of alcohol to 24 hours a day Monday Sunday incl.
 - Provision of late night refreshment from 23:00hrs to 05:00hrs (of the following morning) Monday – Sunday incl.
 - Removal of the embedded restrictions on the licence.
 - To remove the conditions listed in Annex 2 of the current premises licence and replacement with a new operating schedule with updated conditions of licence.
 - To make alterations to the premises as part of a refurbishment.

No further changes to the licence are proposed by this application.

5. Promotion of the Licensing Objectives

- 5.1 The Licensing Act 2003 and regulations require that the Council, as local licensing authority, carries out its functions with a view to promoting the four licensing objectives:
 - prevention of crime and disorder;
 - prevention of public nuisance;
 - public safety
 - protection of children from harm.

5.2 In carrying out its licensing functions, the Licensing Authority must also have regard to Guidance issued by the Home Secretary and its own Statement of Licensing Policy. Members are advised that the following sections of the Worthing Borough Council's Policy may be particularly relevant to consideration of this matter, though of course the Policy in its entirety must be considered. Sections indicated relate to paragraph numbers in the Policy itself:

Prevention of Crime & Disorder

- 4.10 In accordance with Section 17 of the Crime and Disorder Act 1998 the Council is under a duty to exercise its functions with due regard to the likely effect on, and the need to do all it reasonably can to prevent, crime and disorder in its areas. The possible crime and disorder implications are clearly relevant factors in the consideration of all applications and this is re-emphasised by the Licensing Act 2003 itself, the Guidance issued under section 182 to the Act and this policy. The Council will give "due regard" to all possible implications and its Licensing & Control Committee will always consider all the information available and relevant representations made, including those from the public and the responsible authorities, particularly the Police.
 - 4.15 In addition to the requirements for the Council to promote the licensing objectives, it also has a duty, as detailed in paragraph 4.10, under Section 17 of the Crime and Disorder Act 1998 to do all it reasonably can to prevent crime and disorder in the Borough. The Council will consider attaching conditions to licences and permissions to deter and prevent crime and disorder within the vicinity if relevant representations are received. Whether or not incidents can be regarded as being in the vicinity of licensed premises is a question of fact and will depend on the particular circumstances of the case.
 - 4.9 The Council recognises that the Licensing Act is not the primary mechanism for the general control of nuisance and anti-social behaviour by individuals once they are away from licensed premises. Nonetheless, it is a key aspect of such control and licensing law will always be part of a holistic approach to the management of the evening and night time economy in town centres.

Prevention of Public Nuisance

- 4.24 Licensed premises, especially those operating late at night and in the early hours of the morning, can cause a range of disturbances impacting upon people living, working or sleeping in the vicinity of the premises or wider afield.
- 4.25 Noise disturbance can arise from entertainment or activities held within licensed premises and also from people or motor vehicles outside licensed premises. The Council will expect Operating Schedules to address these issues. Advice and guidance can be obtained from Licensing Officers or the Council's Environmental Protection Team. If representations are received the Council may utilise appropriate conditions to control noise disturbance and the use of such conditions will depend upon the activities/entertainment/hours of operation proposed; the nature of the locality; and existing background noise levels and ambient noise levels. Noise control conditions may include the satisfactory sound insulation of licensed premises; compliance with maximum noise levels; and limiting hours of operation.

- 4.26 When addressing public nuisance the applicant should initially identify any particular issues (having regard to their particular type/construction of their premises, proposed activities and nature of locality) which are likely to adversely affect the promotion of the objective to prevent public nuisance. Such steps as are required to deal with these identified issues should be included within the applicant's Operating Schedule.
- 4.30 The Licensing Authority will consider attaching conditions to licences and permissions to prevent public nuisance, but will seek to avoid duplication with the requirements of other regulatory regimes.

DEMAND, SATURATION & HOURS

6.1 In accordance with the Government's guidance the Licensing Authority recognises that demand is not a relevant criterion in considering an application under the Act.

Alcohol Stores & Supermarkets – Off Sales

- 7.3 The Home Office Guidance to the Act recommends that shops, stores and supermarkets selling alcohol should generally be permitted to match the hours during which they may sell alcohol with their normal trading hours, unless there are exceptional reasons related to the Licensing Objectives, in particular 'the prevention of crime and disorder' and 'the prevention of public nuisance'.
- 7.4 The Licensing Authority will consider all applications on their own merit and will not consider 'need or demand' but If an area is experiencing problems and this is linked to the number of premises in the area already selling alcohol, for consumption off the premises, the Licensing Authority will carefully consider the cumulative impact on the Licensing Objectives of any new application if relevant representation is received.
- 7.5 The Licensing Authority will be particularly concerned with regard to the granting of new licences to stores and supermarkets in localities where the following problems have been identified:
 - Alcohol sales to persons who are drunk
 - Underage drinking
 - Street drinking
 - Pre-loading & post-loading

6. Consultation

- 6.1 The application has been subject to the statutory consultation and statutory public advertisement arrangements in accordance with the provisions of the Act, in respect of which representations have been received from the following:
 - Members of the public Six representations of which three are petitions
 - Responsible Authorities Two representations.

7. Relevant Representations

- 7.1 Details of the representations received are reproduced in full at Appendices E & F. The comments made are considered to relate to the statutory licensing objectives as follows:
 - Prevention of Crime & Disorder
 - Prevention of Public Nuisance.

and relate to the parts of the application listed:

- The extension of the opening hours of the store and the hours for the sale of alcohol to 24 hours a day Monday Sunday incl.
- Provision of late night refreshment from 23:00hrs to 05:00hrs (of the following morning) Monday Sunday incl.

No representation has been made regarding the application to:

- Remove the embedded restrictions on the licence.
- Remove the conditions listed in Annex 2.
- Include in Annex 2 the conditions in boxes b to e of Section 16 of the application.
- Make alterations to the premises.
- 7.2 Sussex Police made representation against the grant of parts of the variation application on the grounds of:
 - Prevention of Crime & Disorder
- 7.3 The Public Health & Regulation's Environmental Protection Team have expressed concerns that the application does not adequately address the objective of:
 - Prevention of public nuisance
- caused by noise and that if the variation is granted as applied for a public nuisance would be caused to residents within the vicinity of the store.
- 7.4 Forty four local residents expressed concerns regarding the noise and disturbance associated with the site and request the extended hours for opening, alcohol, late night refreshment be refused. Members have been supplied with copies of the letters and petitions in their entirety. Some of the content of the representations relates to planning issues and whilst some of this information is considered irrelevant to this application, nothing has been excluded from the letters. Consequently members are reminded that they will need to consider carefully the weight, if any, they apportion to some of the information.
- 7.5 All parties have been invited to attend the Sub-Committee and included in this report are the letters of representation & petitions reproduced in full.

8. Mediation

- 8.1 The Licensing Act 2003 encourages mediation.
- 8.2 Sussex Police and the applicant have been in mediation and have come to an agreement. The Police note that the operating schedule already includes conditions relating to:

Age verification (challenge 25).

in addition the following conditions have been volunteered to the operating schedule should members be of a mind to grant a variation:

1. CCTV

- The premises licence holder shall install and maintain a CCTV system giving coverage of all areas, including the entry and exit, to which the public have access.
- CCTV coverage shall enable frontal identification of customers entering the premises in any light conditions.
- The CCTV system shall continually record whilst the premises are open for licensed activities.
- All CCTV recordings shall be stored for a minimum period of 31 days with the date and time stamping.
- CCTV recordings shall be made available for viewing immediately upon the receipt of a request made by the Police or an authorised officer of the Council.
- A staff member who is conversant with the operation of the CCTV system shall be at the premises at all times when the premises are open to the public and shall be able to facilitate viewing of footage upon the receipt of request from the Police or an authorised officer of the Council.
- 2. Signage informing customers of the age verification policy adopted at the premises will be prominently displayed.
- 3. All staff engaged or to be engaged in the sale of alcohol on the premises must receive the following training in age restricted sales:
 - Induction training which must be completed and documented prior to the sale of alcohol by the staff member.
 - Refresher/reinforcement training at intervals of no more than 6 months.

Training records must be retained at the premises or at the offices of the licence holder for a minimum period of 12 months.

- 4. All cashiers must be trained to record refusals of sales of alcohol in a refusals book/register. The book/register must contain:
 - details of the time and date the refusal was made;
 - the identity of the staff member refusing the sale;
 - details of the alcohol the person attempted to purchase.

The book/register must be retained at the premises or at the officers of the licence holder for a minimum period of 12 months.

- 5. An incident book/register must be maintained to record:
 - all incidents of crime and disorder occurring at the premises
 - details of occasions when the police are called to the premises

The book/register must be retained at the premises or at the officers of the licence holder for a minimum period of 12 months.

6. There shall be no self-service of spirits except for spirit mixtures.

7. The entrance door to the shop will be closed to customers between the hours of 2300 and 0500. Any sales between these hours will be made through the night pay window.

These would become enforceable conditions of any licence variation granted and consequently Sussex Police have withdrawn their representation.

- 8.3 I am aware that the applicant has been in communication with the PH&R Environmental Protection Team to mediate but at the time of the drafting of this report no further information was available as to how this mediation had progressed. Members will be updated in due course.
- 8.4 I am unaware of any mediation between the applicant and the local residents that have made representation and considering the nature of the public representations made a mediated agreement is considered unlikely but Members will be updated of any developments.

9. Consideration

- 9.1 Members must take into consideration the following when determining this application:
 - The four statutory licensing objectives
 - Worthing Borough Council's Statement of Licensing Policy
 - Guidance issued by the Home Secretary
 - Relevant representations made by all the parties
 - The results of the mediation that has taken place
- 9.2 These are the only matters to be addressed by the authority when considering this application. The statutory licensing objectives are the only grounds on which representations can be made, and the only grounds on which an authority will be able to refuse an application or impose conditions in addition to statutory conditions and those proposed by the applicant in the Operating Schedule.
- 9.3 When considering this application for a variation to the premises licence, pursuant to section 35 of the Act the following options are available to the Sub-Committee:
 - a. Grant the variation, as requested,
 - b. Grant the variation as requested, with additional conditions appropriate to the promotion of the specific licensing objectives on which relevant representations have been received.
 - c. Reject the whole or part of the application.
- 9.4 Members are required to give reasons for their decision.

10. Legal Implications

10.1 Under Section 181 and Schedule 5 of the Act, rights of appeal to the Magistrates' Court in respect of applications for variation of an existing licence include:

- (1) The applicant / licence holder may appeal against any decision to modify the conditions of the licence.
- (2) The applicant may appeal against a rejection in whole or part of an application.
- (3) Those that have made relevant representations may appeal against a variation being granted, rejected, or against the modification or lack of modification of any conditions.
- 10.2 Members are reminded that the Act allows for the local licensing authority to undertake a review following the grant of a premises licence, when requested to do so by a responsible authority, such as the police, or the fire authority, or any other person, such as a resident living in the vicinity of the premises. The Government's guidance states: "The proceedings set out in the 2003 Act for reviewing premises licences represent a key protection for the community where problems associated with crime and disorder, public safety, public nuisance or the protection of children from harm are occurring. It is the existence of these procedures which should, in general, allow licensing authorities to apply a light touch bureaucracy to the grant and variation of premises licences by providing a review mechanism when concerns relating to the licensing objectives arise later in respect of individual premises."
- 10.3 In determining this application, the principles of the Human Rights Act 1998 must be taken into consideration and the convention rights of both individuals and businesses will be given due weight.
- Members must consider each application on its own merits, and in accordance with the principles of natural justice as well as the provisions of the Licensing Act 2003. All relevant factors must be taken into account, and all irrelevant factors must be disregarded.
- 10.5 All applications before Committee must be considered against the backdrop of anti-discriminatory legislation, such as the Equality Act 2010 and also in accordance with the Council's stated policy on Equal Opportunities.
- 10.6 In accordance with Section 17 of the Crime and Disorder Act 1998 the Council is under a duty to exercise its functions with due regard to the likely effect on, and the need to do all it reasonably can to prevent, crime and disorder in its areas. The possible crime and disorder implications are clearly relevant factors in the consideration of all applications and this is re- emphasised by the Licensing Act 2003 itself. In giving "due regard" to these possible implications members will consider and weigh up all the information available and representations made, including those from the public and the responsible authorities particularly the Police.

11. Other implications

11.1 Any decision taken will have regard for the local environment and, in particular, any conditions attached for the purposes of preventing public nuisance will take this principle into account.

12. Recommendation

12.1 Members are requested to determine the application made by Malthouse Ltd. for a variation to the Premises Licence at MRH Brooklands – Service Station, Brighton Road, Worthing and give reasons for that determination.



Appendix A – Map of Area






Appendix B Existing Plan of Store

 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or

- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

B. Mandatory conditions: Door Supervision

When employed each such individual must be licensed by the Security Industry Authority.

C. Mandatory conditions: Age Verification

An age verification policy for the premises must be produced, implemented and details made available to authorised officers upon request. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:

- a holographic mark, or
- an ultraviolet feature.

D. Mandatory conditions: Permitted Price

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

For the purposes of the condition "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979; "permitted price" is the price found by applying the formula—

$$P = D + (D \times V)$$

Such evidence is to be of a photographic nature such as a passport or photographic driving licence until other effective identification technology, such as thumbprint or pupil recognition, is introduced.

I refer to the above application copied to us for comment and raise this representation on the grounds of the prevention of public nuisance.

The application site is located immediately adjacent to residential properties. The immediate vicinity is very quiet late at night and during the early hours, so noise is more noticeable and could result in a public nuisance. Noise will be produced from vehicles arriving and departing, loud music from within the vehicles and noise from people. The application contains no information on what controls are to be in place to prevent a public nuisance being caused by noise.

The parts of the application of concern relate to the extension of hours for the sale of alcohol and the provision of late night refreshment. As the application requests opening into a period of the day when the vicinity is relatively quiet, the operating schedule for the prevention of public nuisance (Section 16) must fully address the potential for noise and more importantly, provide adequate safeguards to ensure noise does not cause a public nuisance. I do not consider the proposed operating schedule to be sufficient for this purpose.

For these reasons I must raise this representation on the grounds of the prevention of public nuisance. I have tried to address this matter with the applicant but have received no response. I suggest that the applicant consult with us at the earliest opportunity should they wish to discuss, clarify or amend the current application.

Furthermore the planning permission for this premises does not permit 24 hour operation and neighbours are likely to raise objections to 24 hour opening should a planning application be submitted.

As a Resident, living immediately adjacent to the Petrol Station, I am writing to object in the strongest terms to the proposed variation of the Premises Licence, in particular for the sale of alcohol on a 24 hour basis and, the provision of late night refreshment between 23.00 and 05.00 daily.

When BP was granted planning permission for the reconstruction of the petrol station in 2003 one of the Conditions of Planning to which BP agreed was that Fuel and Retail Sales would be limited to between 06.00 and 23.00. The petrol station would therefore be closed between 23.00 and 06.00. This condition was imposed to minimise continual late night disturbance caused by unruly and noisy customers, which residents had had to endure for the previous years when the petrol station was being


I had occasion to write to Mr Appleton in August 2017 when a new franchisee started to remain open all night, in breach the conditions of Planning Control. Tracey Consterdine, Planning Enforcement Officer, visited the site, and wrote to the new franchisee advising that they do not have permission to operate past the permitted hours, since when the site has complied with the permitted opening hours. (except that all the lights to the forecourt and signs remain on all night, which I consider unnecessary, and a point I have have also raised with the operators, to no avail.)

I enclose for your information copies of correspondence between myself and the Planning Department in respect of the above.

I cannot understand why it would be deemed acceptable to now grant a new Licence, increasing the hours of trading, which would obviously cause the same type of noisy night-time disturbance to which myself and other local residents were subjected previously, when the petrol station operated by the previous owner, Mobil on a 24 hour basis.

At that time I was frequent contact with the Environmental Health Department, complaining of the constant night-time disturbance. If the extension to the Licence is granted I would envisage having to do the same thing again in the future, although I would much prefer quiet nights' sleep.

I apologise for not writing to you carlier but I have only just seen the notice which is pinned to the contractor's fencing. None of my neighbours in the road had seen it either! I should have thought that with such a far-reaching proposal, as an affected adjacent neighbour, I should have received a personal letter from the Licensing Department advising of the proposed changes to the opening hours.

We are writing to object to the proposed variation of the Premises Licence at the Brooklands BP Petrol Station on Brighton Road, Worthing.

We particularly object sale of alcohol on a 24 hour basis and the provision of night refreshment between 23.00hrs and 05.00hrs. This is likely to cause noise and disturbance and increase the unsociable behaviour that already takes place in and around the car park of Brooklands Park. Both young and old and the homeless use this area to take drugs and consume alcohol. With alcohol even more readily available this will only increase such behaviour.

Extended opening hours and sale of alcohol is also likely to increase the amount of litter in the area and on the beach. This is a continual problem which I have frequently drawn to the attention of BP and the managers of the premises.


Due to the disturbance and noise that occurred when the premises were open 24 hours prior to 2003, BP was granted planning permission for the refurbishment of the petrol station at that time only **on condition that fuel and retail sales would be limited between 06.00hrs – 23.00hrs.** There can be no justification for extending the opening hours and sale of alcohol.

It was a neighbour who alerted me to this application, the Notice being pinned to the contractors fencing and where it is not easily seen. With the potential impact on those living in Seamill Park Avenue surely you should have notified each property personally?

Dear Sirs,

I am writing in respect of the application to vary a Premises License submitted by Malthurst Ltd in respect of the site MRH Brooklands, 331 Brighton Road, Worthing, West Sussex BN11 2HP (i.e. the BP Garage site).

It is my understanding that the current license limits opening hours from 5.00AM to 10.30PM (or similar). I believe it is the case that the applicant has, in the past, made attempts to vary their license with the intention of extending the opening hours to 24 hours a day, and I am grateful that the Council have deemed the proposals inappropriate and rejected those application(s).

I understand that under the current application, the applicant has applied to:-

- Extend the sale of alcohol between the hours of 0000 and 2400 daily for consumption off the premises;
- 2. The provision of late night refreshments between the hours of 2300 and 0500 daily;
- 3. To vary the license conditions;
- 4. To make alterations to the premises;

In respect of the 1st three items, I wish to raise my strong objections to these proposals. The garage site is on the corner of Brighton Road and Seamill Park Avenue, the latter being a quiet residential Road. I have very concerned that if this proposal was to receive approval, the houses in Seamill Park Avenue would be blighted by noise and traffic 24 hours a day with no let-up for residents. I also suspect that an outlet which intends to extend the sale of alcohol 24 hours a day could well attract undesirable elements of the community to this peaceful residential area.

I would urge the Council to maintain the restrictions on opening hours currently in place for this site and reject any application to extend them. It would seem to me to be wholly inappropriate to grant a retail


