For the Protection of Children from Harm:

The premises will operate a "Challenge 25" policy whereby any person attempting to buy alcohol or any other age restricted product who appears to be under 25 will be asked for photographic ID to prove their age.

The Premises Licence Holder shall ensure that all staff members (including family members, friends and people who are helping out on a casual or informal basis) engaged or to be engaged, in selling alcohol or any other age restricted product at the premises shall receive induction training. This training will take place prior to the selling of such products:

No more than two (2) children or young persons under 18 shall be permitted in the shop at any time unless accompanied by an adult.

This is a small shop therefore in my view there should be a limit imposed, if they allow a whole group in they could just steal the vapes, tobacco and alcohol.
