Review of polling districts, polling places and polling stations Report by the Director for Sustainability & Resources

Executive Summary

1. Purpose

- 1.1 Local authorities are required to review their polling districts and polling places for United Kingdom constituencies at least once every five years.
- 1.2 The (Acting) Returning Officer has completed a statutory review of polling districts, polling places and polling stations.
- 1.3 The purpose of the review is to assess the size of the electorate in each polling district as well as the suitability of the location and access of each polling place and the number of polling stations located at each polling place.
- 1.4 As a result of the review alternative venues were investigated, and although not as a direct result of the review Members will note the polling station for Manor and Cokeham north polling districts in Adur have a new polling station

2. Recommendations

2.1 The Committee is asked to note the Adur District Council and Worthing Borough Council Polling Station Reviews, Comments and Actions taken during consultation which are detailed in the Appendices to this Report.

3. Context

- 3.1 Although polling stations are informally reviewed following elections every year, this report complies with the Council's statutory duty to carry out a compulsory review of polling districts, polling places and polling stations in the District/Borough at least once in every 5 years.
- 3.2 This review is timed to take into account the Parliamentary Boundary review, in order to publish any changes to the registers of electors by 1 December (and before the next UK Parliamentary election).

4. Issues for consideration

- 4.1 Since 2019 the electorate has decreased in Adur from 48221 to 47507 and in Worthing has increased from 81146 to 81615.
- 4.2 Finding suitable polling places within polling districts can be challenging. Polling places are assessed against:
 - Disabled access
 - Reasonable parking facilities
 - Accessibility to all electors in the polling district
 - Sufficient lighting, heating and space
 - Kitchen and toilet facilities for staff
 - General booking availability, (especially at short notice)
 - Provision of tables and chairs
- 4.3 Based on the review the following changes are being made:

6. Financial Implications

- 6.1 No budget was set for this review. Work was carried out alongside other statutory work undertaken by the Electoral Services team.
- 6.2 The cost of hiring polling stations is funded from within existing budgets; and in the case of Parliamentary, Police & Crime Commissioner, County council, Parish and national referendums will be recharged from relevant authority.

7. Legal Implications

- 7.1 Sections 18A to 18E and schedule A1 to the Representation of the People Act 1983, and Review of Polling District and Polling Places Regulations 2006 provide the steps that must be included in a statutory review of UK Parliamentary polling districts and polling places.
- 7.2 Section 3(1) of the Local Government Act 1999 (LGA 1999) contains a general duty on a best value authority to make arrangements to secure

continuous improvement in the way in which its functions are exercised, having regard to a combination of economy, efficiency and effectiveness.

7.3 Section 1 of the Localism Act 2011 empowers the Council to do anything an individual can do apart from that which is specifically prohibited by pre-existing legislation.
